# 4. MATTERS WHICH REQUIRE DECISIONS

There are no items presented for decision.

#### 5. MATTERS WHICH REQUIRE DISCUSSION

## 5.1 UPDATE ON WANERIE / COORAMINNING ROAD INTERSECTION

The EMTRS contacted MRWA regarding the potential partial funding for this project with MRWA advising that as both roads were recognised WBSRRG roads of significance, that they would be eligible for funding if an MCA was submitted. Any planning or consultancy work related to the project would also be eligible. This project, if funded under WBSRRG funding, would need to be funded potentially over a two-year period under the Shire's amalgamated WBSRRG funding, assuming the project is over \$2M.

The Manager Operations has advised that a Preliminary Land and Geotechnical Survey would be in the vicinity of \$35,000, This would be eligible for funding under WBSRRG as part of the project, which would be my recommendation rather than using municipal funding, however a true cost figure for a MCA would not be able to be estimated due to needing a Preliminary Land and Geotechnical Survey in the first instance hence this figure may need to be funded under Muni funding.

The EMTRS has contacted the landowner's son Mr Peter Furness, who is caring for his father Mr Bill Furness. Peter said that he is open to the conversation regarding the Shire requisitioning the required land for the project however would like to see a concept plan and meet on site to which the EMTRS advised that this would be a good step forward. The EMTRS has made further attempts to contact Mr Furness by phone, however, has been unsuccessful at this time.

The discussion for the Road Reference Group (RRG) could be around where this project would fit into the revised 10-year road program (as presented to the RRG at its last meeting) under WBSRRG partial grant funding, potentially year 11, meaning that the project would be in the future at some stage and or included in year two of the Shire's Long Term Financial Plan. The project may potentially also be funded by some other grant funding i.e., future LRCIP if that funding is available into the future?

Currently this project is not present in the revised ten-year road program. The EMTRS would like some recommendation from the group moving forward to allow for the revised road program to be presented to Council for resolution. The Roads to Recovery grant funding body, still have not announced the amount of funding for 2024/25 and beyond for the next five-year programme, this will also delay the ten-year program being presented to Council, due to the final two kms of Narrogin Valley Road needing to be funded, as discussed at the RRG December 2023 meeting.

# **ACTION:**

The EMTRS offered to further investigate the viability of this project by:

- Record traffic counts for Wanerie & Cooraminning Roads in 2024;
- Investigate the cost of survey works and land tenure;
- To work on an MCA to WBSRRG for preliminary work of land tenure and survey works only in 2025/2026. The preliminary works of land tenure and survey to be included in the revised 10 year Road Program 2024-2034 for Council consideration.

There are no municipal funded footpaths being presented for the 2024/25 financial year at this time due to the above.

- Butler Street 132m from Holmer Street to adjoining High School Bus Stop
- Homer Street 130m from Butler to Argus

- Grey Street 434m from Kipling to Hansard
- Butler Street 130m from Doney to Hansard
- Daglish Street 340m from Ensign to Clayton
- Forrest Street 340m from 82 Forrest to Narrakine.
