The Chief Executive Officer explained that an issue had arisen with regard to the timing of declarations made by the newly elected Councillors.

The *Local Government Act 1995* states that an extraordinary election shall be held if an elected member does not make a declaration in the prescribed form within 2 months of being declared elected. As the three newly elected councillors were declared elected unopposed on the 12th September 2013, they needed to have made their declarations prior to the 12th November 2013. The declarations were made at the first Council Meeting following the Election Day on the 14th November 2013.

To rectify this situation the Department of Local Government and Communities has provided a briefing note to the Minister for Local Government seeking his approval to instruct Parliamentary Counsel to draft the Governor's Order, which will vary the provisions in the Act to overcome this problem.

The Council will still be able to conduct business at this meeting with the four existing Councillors providing the quorum. Unfortunately the newly elected Councillors, being Crs Quartermaine, Borthwick and Ballard will not be able to vote on any matter until such time as the Governor's Order takes effect.

The Chief Executive Officer indicated that a number of local governments had been similarly affected.
