If negative feedback is received the application requires presentation to Council for their consideration, the survey information will become an attachment to the report. The report will be submitted to the next available Council Meeting for a Council Resolution regarding the application.

Once a decision has been made you will be advised in writing by the Shire of Narrogin as to the outcome.

The Shire of Narrogin shall not make a decision with respect to the application until at least twenty-one (21) days after the service of the last of the notices referred to herein and shall take into account a report prepared by a Shire Ranger.

I agree that the Shire of Narrogin may at any time withdraw or amend the terms of any exemption which may at any time be granted with respect to *Section 26 of the Dog Act 1976 (as amended)*.

I agree that the statements herein made by me are correct and I make this declaration in accordance with *Section 106 of the Evidence Act 1906*.

I agree to pay the application fee to the Shire of Narrogin, and understand that this fee is non-refundable.
