## Part 1 - Shire of Narrogin's Request

#### 1.1 Introduction

The Shire of Narrogin invites Expressions of Interest (EOI) from approved and experienced Homecare & Aged Services Providers to acquire and operate the Shire's Regional Homecare Services.

The Shire is considering transitioning out of direct delivery of Homecare services and seeks EOI's from approved providers who can deliver:

- A seamless transition with full continuity of service;
- Commitment to a local presence and local employment;
- Full compliance with aged care regulations; and
- Strengthened sustainability of services for the community.

#### 1.2 EOI Documentation

This Expression of Interest consists of the following parts:

- Part 1 Shire of Narrogin's Request;
- Part 2 Service Specification;
- Part 3 Expression of Interest Submission.

#### 1.3 Submission of EOI's

EOIs must be submitted no later than the closing date and time specified on the cover page. Late submissions may not be considered.

#### 1.5 Evaluation Process

EOIs will be assessed against the Evaluation Criteria contained in this document. The Shire may seek further information or clarification from respondents and may shortlist proponents for further negotiation.

#### 1.6 Evaluation Criteria

EOI's will be assessed against the following criteria:

- Proposed Service Criteria (60%) transition plan, service delivery model, regulatory compliance, experience in Homecare services delivery.
- Local Service Commitment (20%) commitment to local employment, commitment to establishing and maintaining a base of operations in Narrogin, experience in establishing and maintaining local community partnerships.
- Qualitative Criteria (20%) organisational experience and provider status, current organisational structure, current CHSP and CHCP agreements; workforce experience and qualifications, financial viability.

#### 1.7 Exclusions

The Shire of Narrogin Community Assisted Transport Service (CATS) is excluded from the EOI. The Shire of Narrogin will retain the operation of the CATS service.

#### 1.8 Conditions of EOI

The Shire of Narrogin is not bound to accept any Expression of Interest and may discontinue or alter the EOI process at any time. The Shire reserves the right to negotiate with any respondent, or not to proceed with the EOI at its discretion.

## Part 2 - Service Specification

## 2.1 Background

The Shire of Narrogin has provided Homecare services since 1986.

Currently, Narrogin Regional Homecare Services delivers services to approximately 138 clients under both the Commonwealth Home Support Program (CHSP) and Home Care Packages (HCP):

#### Clients (as at 31 July 2025):

CHSP: 105 ClientsCHCP: 33 Clients.

Jessie House is owned by the Shire of Narrogin and may be offered on a commercial negotiated short-to-medium term lease (maximum of four years on a 2+2 year basis).

Alternatively, the Shire may be able to offer other potentially suitable locations in the town of Narrogin, also on a commercial negotiated short-to-medium term lease basis.

The Shire of Narrogin is inviting Expressions of Interest (EOI) from approved and experienced Home Care Package Services Providers to acquire and operate the Shire's Regional Homecare Services as follows:

- Acquire the existing service operations, including client and funding agreements;
- Employ or absorb existing staff where possible;
- Lease the existing facility at 30 Clayton Road, Narrogin, or an alternative facility for base of operations in the town of Narrogin;
- Provide a seamless transition;
- Maintain continuity and enhance delivery service for clients;
- Ensure compliance with aged care legislation and standards;
- Demonstrate financial and organisational sustainability.

#### 2.4 Objectives and Evaluation Criteria

It is essential that interested approved service providers clearly demonstrate in their EOI a commitment to:

- Delivering a seamless transfer with minimal disruption to clients;
- Maintaining a strong local presence and accessibility in Narrogin;
- Maintaining local employment in the delivery of Homecare services;
- Enhancing quality of care and service delivery through innovation, efficiency, and best practice;
- Demonstrating strong governance, compliance, organisational capability and financial management.

# 3.2 Response to Evaluation Criteria

Respondents must ensure their EOI response provides full details regarding:

- Proposed offer and purchase conditions;
- Proposed transition plan and timeline for seamless, full transition and service continuity (including client handover and staff considerations);
- Any conditions related to compliance, transition support and future investment;
- Commitment to maintain a strong local service presence and accessibility in Narrogin;
- Commitment to maintaining local employment in the delivery of Homecare services;
- Interest in the lease of Jessie House (or other facility from the Shire), including preferred lease terms and proposed usage;
- Interest in the acquisition of current fleet vehicles (if any);
- Interest in the acquisition of current office and other equipment (if any);
- Evidence of current Homecare provider approval, sector experience, governance and financial capacity.
- Capability and accreditation in CHSP/CHCP delivery.

#### **Evaluation Criteria:**

**Proposed Service Criteria (60%) -** transition plan, service delivery model, regulatory compliance, experience in Homecare delivery.

**Local Service Commitment (20%)** – commitment to local employment, commitment to establishing and maintaining a base of operations in Narrogin, experience in establishing and maintaining local community partnerships.

**Qualitative Criteria (20%) -** organisational experience and provider status, current organisational structure, current CHSP and CHCP agreements; workforce experience and qualifications, financial viability.
