5. MATTERS WHICH REQUIRE DECISIONS

5.1 BUSH FIRE RISK MANAGEMENT PLANNING UPDATE

Peter Cupitt, Bushfire Risk Planning Officer provided an update which included the following:

The Bushfire Risk Management Plan is complete and been sent to Office Bushfire Risk Management (OBRM) for approved. Once it has been approved it will then to go to Council for endorsement.

Once the plan has been endorsed by the Shire then Mitigation Activity Funds (MAF) will be available to be applied for. It must be noted that work can only be done on Shire managed land or reserves.

450 assets have been identified within the Shire, of these approximately 35-40% are rated high or above. About 12 assets have been identified as being extreme fire risks.

MAF can be sourced for anything high and above and can include:

- Fuel loading reduction by fire brigades such as through burning;
- Fire mitigation through contractors by mulching and spraying.

5.3 RELOCATION OF FIRE UNIT TO HIGHBURY TOWNSITE

The Chief Executive Officer (CEO) sent a letter to all FCO's in January 2020 requesting their thoughts on the relocation of one of the 3.4 Fire Units to the Highbury Townsite. Six (6) responses were received with two (2) being in favour of the suggestion and four (4) being against.

A number of issues were raised including the number/ability of volunteers in Highbury to operate the unit and respond when required.

It was suggested that volunteers from the Highbury area look into becoming trained in the use of the 3.4 Fire Units, they would then be available to assist the current volunteers when required in their area.

ACTION Administration Staff to liaise with DFES Staff to ensure that all FCO's are offered training on the Shire's Fire Trucks at the commencement of each fire season.

5.4 MOBILE STANDPIPES

Guy Maley provided the following information about the mobile standpipes.

There are currently four (4) mobile standpipes located in the Shire of Narrogin, these are located in Ockley, Narrogin East, Minigin and Highbury East.

There were concerns expressed that there was a fire and the closest Shire Standpipe was broken, the brigade was unable to source a mobile standpipe.

It was recommended that all brigades be made aware of the location of all of the mobile standpipes in the Shire so that they know who to contact if the situation should arise again. It was also recommended that the Shire purchase some additional mobile standpipes.

ACTION Administration Staff to ensure that all FCO's are aware of the location of all mobile standpipes including the Shire's one.

ACTION Shire Staff to ensure that the mobile standpipes are serviced and returned in a timely manner.

COMMITTEE RESOLUTION

That it be a recommendation to Council that two (2) new mobile standpipes be sourced, preferably, through the Emergency Services Levy (ESL), and prior to the next fire season.

5.5 WHATSAPP

Stuart Moyses advised that the WhatsApp application is being successfully used by the 'Narrogin Fire Group' as a tool to keep FCO's and local farmers informed on what is happening in the area. Unfortunately it is starting to be used for general chat and the administrators, Stuart Moyses and Dani Porter, are concerned that people are being inundated with chatter which can lead to people ignoring messages, assuming them to be chat when it could be important information.

The administrators of the app have requested the Shire's assistance in formulating and enforcing communications policy on the app to ensure that only important messages are being sent.

ACTION: Stuart to send the draft rules to the Executive Support Officer.

6. NEW BUSINESS OF AN URGENT NATURE APPROVED BY THE PERSON PRESIDING OR BY DECISION OF THE MEETING

- It was noted that early in the fire season a ban notification was sent out through the SMS system but a message was not able to be sent advising that the ban had been lifted as there were insufficient credit available on the SMS system. This cause some confusion and criticism.
 - ACTION Administration Staff to ensure that there is sufficient credit at the start of the fire season and that staff are aware of the process and procedure to purchase more should it be required out of business hours.
- It was suggested that Brigades educate their members about 'chaff dumping' and ensure that when burning permits are issued the person being granted the permit is aware of their obligations as printed on the permit, ie check the weather forecast and ensure sufficient breaks.
- A note of thanks was given to the Rangers for all of their assistance.
- FCO's are permitted to close roads and do whatever else needs to be done in the performance of their role in an emergency situation.

• It was advised for information that the SES and BFB are looking at having a joint facility. There will be a meeting of the volunteers to discuss this. The funding for the co-located facility would come from the ESL.

There being no further business to discuss, the Acting Presiding Member declared the meeting closed at 6:04 pm

AUTOMATED EXTERNAL DEFIBRILLATORS - LOCAL GOVERNMENT GRANT SCHEME ROLLOUT

The following information is provided to update you on previous correspondence announcing the recognition and implementation of Automated External Defibrillators (AEDs) through Local Government Grant Scheme (LGGS) funding.

The purpose for supplying you with AEDs for Bush Fire Brigades (BFBs) and State Emergency Service (SES) Units is to protect the lives of volunteers while they provide invaluable emergency response services to your community.

The contract for the supply and delivery of the defibrillators has been awarded to a Western Australian regional provider, LFA First Response Pty Ltd, which is based in Northam.

LFA First Response will deliver the units direct to your office on the basis that we are providing one unit for each LGGS funded motorised fleet asset including SES All Terrain Utility and Flood Rescue-boats.

Delivery is expected to occur through June 2020. You will not be invoiced for the AED's however a supplementary grants advice will be issued to recognise the funding allocation.

Attachment 1 – Additional Information, contact and warranty details About AEDs

AEDs are a portable device that automatically diagnoses life-threatening cardiac arrhythmias and treats them through defibrillation.

While AEDs are designed for use by non-clinical users, it is recommended local governments review their volunteer training requirements to ensure they maintain sufficient numbers of trained personnel (in first aid) in preparation for the rollout.

Most first aid training providers have incorporated the use of AEDs into their first aid courses. Where training for Brigades and Units is initiated through the local government, the expenditure is eligible through operating grant allocations. Volunteer first aid training requirements may also be coordinated through your DFES Regional Office, courses provided through the DFES First Aid contract (e-Academy pathways - HLTAID003 Provide First Aid) include defibrillation as a course component. Costs for this training is also met by DFES.

To assist with training requirements that may be delivered locally, one (1) AED training unit and training electrode pads (adult and child) will also be provided per local government.

AED Make and Model, Supplier and Warranty Details

The selected AED, is the HeartSine Samaritan 360P model, will be provided as a 'kit' which includes the defibrillator unit, user guide, adult electrode Pad-Pack (one pair), child electrode Pad-Pack (one pair) and a protective hard case. The units are maintenance free, self-test for faults on a weekly basis with no user input required. An instructional video (in PDF format) is also available for e-mail.

LFA has given options for Wi-Fi based online portal to monitor defibrillator readiness. An optional HeartSine Gateway self-powered Wi-Fi based communication module will communicate via Wi-Fi with LIFELINKcentral AED Program Manager and LIFENET System to enable AED's to be managed across single or multiple locations.

LIFELINKcentral AED Program Manager monitors AED programs by tracking AED readiness status, PadPak expirations, CPR/AED training certificates and more.
