Summary

The Local Government Act 1995 requires that Council accepts the draft Annual Report each financial year, including the Financial and Auditor's Reports, no later than 31 December or within two months of the Auditor's Report becoming available, if that is not received prior to 31 December.

The Auditor's report was received on 21 December 2022. The Audit Advisory Committee will meet with the Auditor on 8 February 2023 (prior to the scheduled Council Meeting) and officers have recommended to the Audit Committee and the Council to accept the Annual Financial Statements and Independent Audit Report.

Background

Under Section 5.53 of the Local Government Act 1995, the Shire is required to prepare an Annual Report for each financial year. The report is to contain:

- A report from the Shire President and Chief Executive Officer;
- An overview of the Plan for The Future/Community Strategic Plan;
- The 2021/22 Financial Report;
- The 2021/22 Auditor Report; and
- Any other prescribed information.

Council is also requested to give consideration to determining the date, time and location of the Annual General Meeting. The meeting must be held within 56 days from the date Council accepts the Annual Report and Financial Statements.

If Council accepts the Annual Report at this meeting, the latest possible date for the meeting is Wednesday 5 April 2023.

Consultation

Consultation occurred with the Auditors and:

- Manager Corporate Services;
- Executive Management Team; and
- Audit Advisory Committee (8 February 2023).

Statutory Environment

The following statutory implications relate:

Implications

There are no known policy implications on this matter.

Financial Implications

Given the Audited Financial Report has a carried forward (30 June 2022) actual surplus only \$11,000 (approximately) less than to the current Adopted Budget's brought forward (1 July 2022) surplus, there are no significant financial implications to consider. This will be addressed as part of the major Budget Review, scheduled for Council consideration at the Council meeting of 22 February 2023.
