#### 5.1 COVID-19 – Agency Reports (updates, issues or concerns)

#### Nigel Hasson - A/DFES - Narrogin Regional Officer

 Nothing to report, business is continuing with sufficient staff available to cover for any away with Covid at any time.

#### Anika Keeling Narrogin SES

Nothing to report re Covid.

#### Sgt Mike Williams WA Police - Narrogin

- Currently impacted by Covid among staff. Services are reduced (about 80%), with staff from other outlying areas being called in to provide support.
- There will be a big funeral in town tomorrow and there are plans for additional staff to be in town to assist.

#### Azhar Awang – Executive Manager Development & Regulatory Services (EMDRS)

• We had the sudden death of our Manager Environmental Health Services which has impacted on workloads within the Shire.

#### Jenny Menasse – WACHS-Wheatbelt –Operations Manager

- Vaccination Clinics are running regularly.
- Hospital visits are restricted to two visitors and they must provide proof of vaccination and wear a mask.
- Patients scheduled for chemo and surgery must have a negative RAT before admission.
- There are staff shortages due to Covid.
- St John Volunteers in smaller surrounding areas are under stress because of Covid.
- Acute transport transfer system may be reduced to 7:00am to 7:00pm.
- Mental Health Services are an ongoing issue with staff away with Covid.
- The "tent" where PCR testing is conducted is very cold, plans are being made to reduce the operating hours.

- DFES are running a lot of training over the next few months, and would like the Shire to promote the training to be held in Narrogin.
  - Rural Fire Awareness 16 August

     This training covers fire control strategy and is recommended for FCO's.
  - Fire Weather 1 8-9 July (4 hours Friday evening and Saturday)
     This training provides information on collecting and interpreting weather information.
  - AIIMS (Australasian Inter-service Incident Management System) 20-21 August (see attached information).

#### Anika Keeling Narrogin SES

- SES are busy with recruiting, training and also responding to storm damage.
- Shire requested to continue promoting the SES.

#### <u>Cr Graeme Broad</u> <u>Councillor – Shire of Narrogin</u>

The Bushfire Recovery group subcommittee are now meeting less frequently, most of the tasks have been completed with the exception of ongoing mental health awareness.

- BlazeAid are working on fences,
- WaterCorp supplied some bottled water,
- Regeneration of parklands and reserves will be a long process.
