- 3. Propose to the Shire of Cuballing the amended Terms of Reference for the Joint LEMC and which includes representatives from that Shire as per attachment 2.
- 4. Subject to the Shire of Cuballing agreeing to form a Joint LEMC and the proposed Terms of Reference, they are hereby endorsed for the purposes of having them approved by the State Emergency Management Committee.
- 5. Inform the State Emergency Management Committee of the Shire's support for a proposed Joint LEMC between the Shire of Narrogin and the Shire of Cuballing.
- 6. Write to the Shire's of Cuballing and Wickepin advising of the above outcomes".

We received notification last week that the requested amendments to the AWARE Grant, specifically the removal of the Shire of Wickepin, have been approved. These changes will be presented to the State Emergency Management Committee for endorsement at their next meeting.

5.2. Amendments to State Hazard Plans

On 8 May 2024, the SEMC approved the comprehensive review of the State Hazard Plan - HAZMAT which provides an overview of arrangements for HAZMAT emergencies in Western Australia.

The comprehensive review was completed by the Department of Fire and Emergency Services, distributed for broad consultation between 17 November 2023 and 12 January 2024 and endorsed by the Response Policy Subcommittee prior to submission to SEMC for approval.

The new State Hazard Plan- HAZMAT and State Hazard Plan - Hostile Act can be viewed via the <u>SEMC website</u> as well as a <u>detailed summary of amendments</u>.

Jennifer Pidgeon - Red Cross Australia

Jennifer gave a presentation on the roles and responsibilities of the Red Cross. A copy of the presentation is attached (Attachment 2).

Craig Smith – Department of Fire & Emergency Services (DFES)

- Volunteer numbers have remained static.
- The State Hazard Plan fire is under review.
- Emphasis is currently on fire safety in the home with stress on the dangers posed by lithium batteries.
- DFES now preparing for the storm season.
- One day SES leadership development training was recently conducted.
- Internal exercises are planned to test emergency arrangements.

Maria Lee – Department of Biodiversity, Conservation & Attractions (DBCA)

The DBCA Report for June 2024 is attached (Attachment 4).

- Conducted hazard reduction burns including 200 ha in the Dryandra woodland.
- Improving access to the airstrip.
- Avian flu is on the radar, not in WA yet.

Azhar Awang – Shire of Narrogin

- Still some volunteer training outstanding. Training is now online.
- Grant application has been submitted for the proposed joint facility for VBFB & SES.
- Shire mitigation works are 80% complete, the volunteers did a great job on the prescribed burn at Foxes Lair.
- Looking into funding for additional/larger water tanks around the Shire to ensure water availability in the case of fire.

<u>Charlotte Powis – DFES – District Emergency Management Advisor</u>

Role and Scope of Committee

- 1. In accordance with Emergency Management Act s.38(2) the specified area of responsibility is the whole of the Shire of Narrogin.
- 2. To identify emergency risks or hazards in the community and arrange to establish, maintain and test the Local Emergency Management Arrangements established to mitigate the risks or hazards.
- 3. To encourage and maintain communication and joint exercises between all stakeholders.

- 4. To prepare and instil prevention, preparedness, response and recovery plans for a variety of identified risks or hazards preventing or minimising the effects of emergency events.
- 5. To increase the number and relative awareness of programmes through community awareness campaigns designed to make the community more resilient.
- 6. To undertake the Community Emergency Risk Management process.
- 7. To carry out other emergency management activities as directed by the State Emergency Management Committee or prescribed in the Emergency Management Regulations 2006.
- 8. To prepare and submit each financial year an annual report of its activities in accordance with the requirements of the State Emergency Management Committee.
- 9. To prepare an annual business plan in accordance with the requirements of the State Emergency Management Committee.
- 10. The Local Emergency Management Committee does not have the authority or power to commit the Shire of Narrogin or the Shire of Cuballing to expenditure without the Shires endorsement.



Superintendent Craig Smith proxy for DFES District Officer

- Charlotte Powis is District Emergency Management Advisor (DEMA) direct link from LEMC to DEMC to SEMC. Advice on compliance issues.
- Static number of volunteers within Region some areas increased. Recruitment program identified to improve volunteer capacity in identified areas.
- High Threat Period (Summer bushfire season) officially over but still potential for fire in the landscape when conditions are suitable. Storm season increases risk with a number of storms already experienced in the South.
- State Operational Fleet of appliances enhanced resources over the summer period. These have now been redeployed to the north of the state for their increased fire risk.
- State Hazard Plan Fire is about to undergo a review. Input sought form stakeholders.
- Smoke Alarm change your battery campaign. 1 June was delayed from 1 April this year. Please check your smoke alarms and advise your staff for home fire safety.
- Home Fire Safety campaign. Media campaign to remind community of risks involved in homes during winter period, and actions to keep everyone safe. Please refer to information provided and seek further through DFES.
- Southern Storm Season. Take preventative measures with storms and potential for flooding.
- Training. Identifying and closing gaps in volunteer units for skill enhancement to required level of functionality. IC/IM roles a whole of agencies approach.
- SES Leaders Development program 6 July. Enhanced information for SES units to reduce community risks.
- Regional Leaders Forum 10 August.
- WAFES Conference 6 September. Statewide opportunity for gaining and sharing knowledge and experiences.
- Internal exercises 2024 to test and improve Regional operation functions.
- Support to LEMC/Agencies in testing local emergency management arrangements.
- Post summer season debriefing. Lessons learned and improved capability opportunity for future and to drive programs such as recruitment, risk management, prepared communities.

STATE NEWS

The last meeting of the State Emergency Management Committee (SEMC) was held 8 May 2024 with the next meeting scheduled for 7 August 2024. SEMC Communiques can be found here.

STATE CONSULTATION REQUESTS

Review - State Hazard Plan Fire - DFES

The Department of Fire and Emergency (DFES) is progressing a comprehensive review of the State Hazard Plan - Fire. This strategic level plan provides an overview of arrangements for the management of fire emergencies in Western Australia.

For the initial phase of the review, DFES is seeking feedback on the existing <u>State Hazard Plan</u>-Fire from agencies with responsibilities within the Plan, including Local Government.

For further information and to provide feedback go to the <u>State Hazard Plan - Fire consultation</u> <u>webpage</u>.

This initial phase of consultation closed on Friday 31 May 2024.

WALGA asked Local Governments to provide a copy of their feedback to inform WALGA comments on the Plan via <a href="mailto:ema

Feedback received will inform DFES' development of a draft State Hazard Plan - Fire and proposed amendments which will be provided for broad consultation with emergency management stakeholders during June and July 2024. WALGA will prepare a submission on the Plan on behalf of the sector.

Review - State Recovery Arrangements in the EM Framework - DFES

The Department of Fire and Emergency Services (DFES) is undertaking a review of state level recovery coordination and governance arrangements provided in the State Emergency Management Framework.

The purpose of the review is to better define when and how the state government will provide recovery coordination support to local governments and communities following emergencies. This will include clarifying the role, membership, responsibilities and accountability of key state level recovery coordination positions and groups and the DFES Resilience and Recovery Portfolio.

The review will not change the role and responsibilities currently held by local government under the Emergency Management Act 2005 and State Emergency Management Framework, however it will clarify the circumstances and arrangements for state support to local governments and/or involvement of a state appointed recovery coordinator.

Disaster Recovery Funding Arrangements are <u>not</u> a focus of this review.

Local Government Focus Group Sessions

As part of the review, DFES will conduct 2-3 focus group sessions in June with local government representatives that have recent disaster recovery experience. The purpose of the focus group sessions is to test the policy options and obtain preliminary feedback to inform the review.





All local governments and the emergency management sector will have the opportunity to review the proposed changes and provide feedback via a formal three-month consultation period later this year. The consultation period will include a program of webinars and engagement sessions for local government.

Review - State Support Plan- Animal Welfare in Emergencies

Department of Primary Industry and Regional Development is undertaking a comprehensive review of <u>State Support Plan – Animal Welfare in Emergencies</u>. The purpose of the State Support Plan - Animal Welfare is to provide the community of Western Australia, including emergency services and the animal management sector, with a document that integrates arrangements for animal welfare with the State's formal management arrangements to ensure that animals are planned for and their welfare is appropriately addressed in any emergency.

The DFES State Emergency Management Policy Branch is now seeking broad stakeholder feedback on the proposed amendments and welcomes other questions or comments you have in relation to this Plan via Engage WA Emergency Management.

The consultation period is open now until the 12 August 2024.

WA Emergency Management Sector Adaptation Plan Discussion Paper

The State Emergency Management Committee (SEMC) is developing the Emergency Management Sector Adaptation Plan (EM-SAP) to support Local Governments advance climate change adaptation and emergency management goals together.

The EM-SAP will be one of seven sector-based plans delivered to help implement the <u>Western Australian Climate Adaptation Strategy</u>. An <u>EM-SAP Discussion Paper</u> has been released to gather input from EM stakeholders about sector-specific adaptation actions.

WALGA coordinated a targeted consultation with Local Governments to inform this pivotal SEMC initiative. WALGA held an **EM-SAP Information Webinar on 14 February** and **Interactive Workshops for Local Governments on 20, 21 and 26 February** to collaboratively explore the questions posed in the EM-SAP Discussion Paper.

Broader community consultation on the discussion paper has now closed with the delivery of the final EM SAP expected in mid-2024

STATE ADVICE

Amendments to State Emergency Management documents

On 6 March 2024, the SEMC approved the comprehensive review of the State Hazard Plan – Crash Emergency which provides an overview of arrangements for the management of crash emergencies in Western Australia. The Plan can be viewed via the <u>SEMC website</u>.

At the March meeting, the SEMC also approved an extension for the comprehensive review of:

- State Hazard Plan Energy Supply Disruption (to August 2024)
- State Hazard Plan Human Biosecurity (to December 2024).

Amendment to Traffic Management during Emergencies Guideline





The SEMC Executive Officer has approved a statement of fact change to the Traffic Management During Emergencies Guideline in support of the Wooroloo Bushfire Review Recommendation 8: DFES should consider establishment of road clearing capability to complement bushfire response, with the sole purpose of clearing roads to provide safe return of residents as soon as possible after fire.

The 2023 Emergency Preparedness Report

The 2023 Emergency Preparedness Report has now been released. This report is a snapshot in time of the level of emergency management capability and preparedness we have, as a state, to manage before, during and after emergency events. It highlights our strengths, weaknesses and areas for improvement statewide, and combines the input from about 170 agencies.

2023 Emergency Preparedness Report

Local Emergency Management Committee Handbook and useful tools

The <u>LEMC handbook</u> provides local governments with a summary of the actions and best practice principles as required under section 38 – 40 of the Emergency Management Act 2005, State Emergency Management Policy, procedures, and guidelines.

The LEMC Handbook provides a summary of the WA emergency management arrangements, key roles, and responsibilities and best practice advice for the administration of LEMC.

The Handbook also includes sample LEMC Terms of Reference and Meeting Agenda templates, which can be downloaded from the SEMC website.

Disaster Recovery Funding Arrangements

Natural disasters or terrorist acts can result in large-scale expenditure in the form of emergency and recovery assistance. To assist with this financial burden, the Australian and Western Australian governments have joint arrangements in place to provide financial assistance in certain circumstances. These arrangements are referred to as the Disaster Recovery Funding Arrangements Western Australia (DRFAWA) and are administered by the Department of Fire and Emergency Services (DFES) on behalf of the WA State Government.

Recovery from disasters is a shared responsibility between individuals, households, businesses, communities and governments. The arrangements are designed as a safety net when costs to undertake recovery activities from an eligible disaster become significant.

For assistance to be made available under the DRFAWA, the event must meet all three of the following criteria:

- 1. The event was one or a combination of the ten specified disasters including bushfire, earthquake, flood, storm, cyclone, storm surge, landslide, tsunami, meteorite strike, tornado; or the event was a terrorist act.
- 2. A coordinated, multi-agency response was required.
- 3. Eligible expenditure relating to emergency assistance, damage to essential public assets and/or other eligible assistance provided in relation to the event exceeds \$240,000 across the affected local government areas.

The National Disaster Risk Reduction (NDRR) grant program

The National Disaster Risk Reduction (NDRR) grant program is established under a National Partnership Agreement (NPA) on Disaster Risk Reduction (2019-2024). It seeks to proactively reduce the risk and limit the impact of disasters associated with natural hazards on Western Australian communities and economies.

All-West Australians Reducing Emergencies (AWARE) grant program.

The All-West Australians Reducing Emergencies (AWARE) grant program for 2024-25 will open at 8 am, 20 May 2024 and close at 12 noon, 1st July 2024.

Funding:

• The 2024 round has a total allocation of \$200,000.





- Projects could apply for between \$2,500 \$35,000 (no GST applied), including local level risk assessment projects.
- Applicants must contribute at least 25 percent of the total project cost in cash and/ or in-kind.

Eligible project types:

- Furthering the emergency risk management process
- Facilitating capability-based exercises
- Assistance in reviewing Local Emergency Management Arrangements (LEMA)
- Delivering emergency management training, events, or forums

WACHS Representative Report

1. What is your current capability for managing incidents/responses? (Do you have enough trained and/or experienced people, resources)

Response: On the 11 June 2024 WACHS Wheatbelt staff participated in Major Incident Medical Management and Support (MIMMS) training. MIMMS is a structured course for clinicians that teaches a systematic approach to managing and responding to an incident. The course was run by the Disaster Preparedness and Management Directorate (DPMD), Department of Health. Resources from this unit are also available to be deployed if required in an emergency. All Health Services in the Southern Wheatbelt have well developed Emergency Response Procedures and Business Continuity Plans (BCP) and training is mandatory.

2. What is your capacity (such as volunteer numbers) and resources looking like for the future? Do you have a volunteer recruitment strategy?

Response: WACHS Wheatbelt has several volunteers in the region however we are in the process of developing a volunteer recruitment strategy to ensure better governance of our volunteers and increase numbers in the future.

3. Are there any new or emerging risks which might impact on your organisation (changes to legislation, seasonal outlooks, new industrial developments)

Response: There is always the risk of future Pandemics and Heatwave which Health is the lead agency.

State-wide audit evacuation centres

- Department of Communities (Communities) is conducting audits of the State's nominated evacuation centres.
- The audits are to identify hazard-specific risks relevant to the region and to identify opportunities for local governments to upgrade facilities to mitigate these risks.
- Communities would like to engage with local governments (LGs) and WALGA to discuss
 opportunities through the Disaster Ready Fund grants for 2025 to improve these facilities
 and mitigate risks in emergency events.

Disaster Ready Fund

Several LGs in Western Australia (WA) submitted applications for the Disaster Ready Fund (DRF) in 2024 to support the improvement of their facilities used as evacuation centres.

Communities had the opportunity to review LGs applications for the Disaster Ready Fund (DRF) provided to the Department of Fire and Emergency Services (DFES) for 2024 and assessed that the projects would contribute to the State's ability to provide emergency accommodation for evacuating communities. All applications were considered suitable to progress for further consideration in the DRF process.

 Can all LEMC members please identify staff that require training. Ideally it would be best suited to conduct this training in a gazetted evacuation centre.

Communities 2023/24 High Threat Season Activations

The Communities Emergency Relief and Support (ERS) Directorate would like to acknowledge and thank all of our local and state partners for the assistance and support provided over the 2023-24 season.

Since October 2023, there has been a total of 40 events supported by Communities including:

- Activation under the AUSRECEPLAN– Israel and Gaza repatriation
- Pre-planning undertaken for 3 high threat weather events, that didn't result in activation.
- 457 people were supported during events through our client management system
- 1 active and declared recovery event (under Disaster Recovery Funding Arrangements)
 Mariginiup Fire.
- just prior to Christmas 2023, there were 6 activations supported by Communities over just 2 days (20-22 December).

Our team looks forward to working with you all over the coming months as we prepare for the 2024-25 season.

Communities Recovery Activities

1. Kimberley Floods Recovery Program

- The Kimberley Floods Recovery program has moved into its second year, with a revised focus on community resilience and wellbeing with an aim of creating a way forward for the community post the floods.
- Communities maintains community recovery officers at the Fitzroy Crossing Flood Hub
 operated by the Shire of Derby West Kimberley, working in partnership with the Shire,
 DFES, DPIRD and other partner agencies to deliver the outcomes of the State Recovery
 and Resilience Plan.
- <u>Kimberley-Floods-State-Recovery-and-Resilience-plan-2023-2024.pdf</u> (website-files.com)
- Communities is managing the recovery needs of individuals, families and communities impacted by the flood. This is called the Social domain and is focused on safety, security, shelter, health, the psychosocial wellbeing of displaced individuals and community resilience.
- Communities also manages a component of the infrastructure and built environment Domain, with recovery activities focussed on clean-up, repair and reconstruction of buildings homes and roads.

2. Mariginiup Fires Recovery Program

• Communities is supporting the City of Wanneroo to deliver the psychosocial wellbeing and financial support elements of the recovery program.

Communities Recovery Activities

- Communities has engaged several psychologists to support impacted resident referrals
 and has delivered a financial assistance package aimed at supporting the replacement of
 essential household items damaged in the fires.
- Communities is currently supporting the City with site visits to damaged properties to commence the clean-up program to ensure residents have access to support services if required.
