MOTORBIKE TRACK

Cr Ballard raised an issue that was discussed in the Chief Executive Officer's Information Report regarding a request from a resident in Highbury to obtain permission to ride in the bush reserve on the west side of the Highbury townsite. He expressed concern that to continue to deny access to sites encouraged riders to take their motorbikes on rail reserves and to other unsuitable locations.

The Chief Executive Officer indicated that the Department of Parks and Wildlife recently opened a motorbike track in a reserve in the northern suburbs of Perth that is open to the public and controlled to ensure the safety of riders. The Chief Executive Officer was asked to obtain information on this project to review its application in this area.
