4. MATTERS WHICH REQUIRE DECISIONS

4.1 REVISED TEN YEAR PLANT & FLEET REPLACEMENT PROGRAM 2025 – 2035

At its last meeting held on 27 February 2025, the Road Reference Group (RRG) was presented with the 2025/26 proposed capital works projects for roads, footpaths, and plant/fleet replacement. These projects were drawn from the respective ten-year programs previously adopted by Council.

During the meeting, the Administration advised the RRG of the operation need for an additional utility vehicle to improve maintenance efficiencies and volume of works within the rural road network – specifically for tree pruning, drainage and gravel road grading. The RRG supported this initiative and recommended that the Administration revise the current Ten-Year Plant & Fleet Replacement Program 2024 – 2034 to include the additional utility. The revised program would then be brought back to the group for comment.

The Administration further advised that this would be a prudent exercise to revise the program, due to the increased purchase costs across the board when precuring plant and fleet.

The Executive Manager Corporate and Community Services and the Manager of Operations collaborated to prepare a revised program, capturing estimated purchase and trade in values of plant and fleet, based on recent procurement and disposals. There was also emphasis to provide a modest and conservative annual reserve contribution. The program was presented to the Chief Executive Officer and the Executive Manager of Technical & Rural Services (EMTRS) who endorsed the program to be presented to the RRG for comment prior to being recommended to Council for resolution.

The draft revised Ten-Year Plant and Fleet Replacement Program 2025-2035 is presented as Attachment 1 for consideration, comment, and recommendation to Council. The EMTRS has also prepared a draft report to Council, presented as Attachment 2, that will give the RRG commentary around the revised program. This report will be finalised following the outcome of this item at the current meeting.


