9.A.225 **AMALGAMATION**

MR AARON COOK AND CR ROB MADSON ATTENDED THE MEETING AT 11:28AM.

The Chief Executive Officer presented an overview of the Shire of Narrogin's involvement in the Regional Transition Group, which has culminated in the Council coming to a point where it is to decide whether to support an amalgamation. In the presence of the Deputy Mayor Cr Rob Madson and CEO Aaron Cook, a number of issues were discussed relating to the Town of Narrogin's position on the proposal and the Council's support for amalgamation that was affirmed at a meeting on the 16th April 2012.

The Chief Executive Officer suggested that the wording in one of the dot points in the recommendation should be revised. Specifically, it related to the item dealing with phasing in of rate increases, and the revised wording needed to reflect that an increase to achieve parity must be in addition to any required annual increase.

There was also discussion on the fifth dot point under the third item in the recommendation. There was consensus that the use of the wording "It is expected that..." does not emphasise the importance of the State Government fully funding the transitional cost and that those words should be removed.

- That the Shire of Narrogin resolves to amalgamate with the local governments of the Town of Narrogin and Shire of Cuballing and submit a proposal for amalgamation to the Local Government Advisory Board for implementation in accordance with the provisions of Clause 2 of Schedule 2.1 of the Local Government Act 1995;
- 2. That the attached supporting documents which set out the nature of the proposal, reasons for making the proposal, the effects of the proposal on the local governments and accompanying plan illustrating the new local government boundary, be submitted to the Local Government Advisory Board;

- **3.** The following items be agreed to by the Minister for Local Government and Multicultural Affairs prior to the submission of the proposal to the **Local Government Advisory Board:**
 - The number of Councillors in the new local government for the first four years should be seven with two from the Shire of Cuballing and the Shire of Narrogin and three from the Town of Narrogin with the President/Mayor being elected from within Council;
 - Commissioners of the new local government to be an elected member from each of the amalgamating local governments and an independent Chair appointed by the Minister for Local Government following consultation with the amalgamating Councils;
 - The State Government agree to the conversion of the Crown Grant on Lot 36 Federal Street, Narrogin (i.e. Shire of Narrogin Administration Centre/Council Chamber) to Freehold Title at no cost to the local government;
 - 1 January 2014 to be the target date for the creation of the new local government;
 - The Transitional consideration reference document is designed to give an overview of the tasks, complexity and duration of a potential transition if a merger proceeds. It also outlines the potential budget that will be requested from the Department of Local Government to support the creation of an amalgamated local government. Government will entirely fund the total cost of tasks required during the transition period;
 - Any increases in rates to achieve parity between the rate in the dollar of the amalgamating local governments be phased in over a period of up to five years and be applied in addition to required annual rate increases.
- 4 That the Minister for Local Government and Multicultural Affairs further consider the requests for additional funding to assist in the amalgamation and transitional process made on the 12th April 2012 at the Town of Narrogin:
 - The three local governments move to a uniform Financial Operating System within the 2012/13 financial year, under a repayment plan over a period of three to five years, and the Minister for Local Government agree to cover the cost of these repayments for purchase and installation as part of the amalgamation process and Transitional costs;
 - That the Minister for Local Government agree to fund the cost of constructing a new Administration Centre and Council Chambers or renovating the existing Town of Narrogin facilities for the new entity as part of the cost of amalgamation;
 - That the Minister for Local Government fund the required amendments to the Key Transitional Documents prepared by KPMG from the savings incurred from the removal of the Shire of Wickepin from the amalgamation process and that this be performed immediately.
