5.1 2018/2019 COMMUNITY CHEST APPLICATIONS FROM ELIGIBLE ORGANISATIONS

BACKGROUND

The 2018/2019 Budget was adopted by Council at the Ordinary Meeting held on 25 July 2018 with an allocation of \$25,000 to the Community Chest. The grant provided to Narrogin Gymnastics Club from the 2017/2018 Community Chest was not carried over to the new budget. It therefore needs to be drawn from the 2018/2019 allocation, leaving an available balance in the 2018/2019 budget of \$22,500 for eligible community groups.

Nine applications requesting cash totalling \$21,416.88 have been received for the 2018/2019 Community Chest for a range of projects including equipment and facility upgrades and coaching clinics for young athletes.

BACKGROUND

Narrogin Toy Library Inc is seeking \$1,000 to support the project Toys for Tikes to purchase new toys and packaging boxes where required for children to focus on developing their skills. Narrogin Toy Library Inc wish to purchase toys that contribute in children developing cognitions, communication and physical skills and enhancing their social interaction and sensory awareness.

SUMMARY

The Toys for Tikes project will purchase new toys for the library. Many of the older toys are suffering from wear and tear; pieces are missing or broken or have just lost their appeal to a new generation of children.

COMMENT

The total project cost is \$1,500. The Narrogin Toy Library is contributing \$500 cash and \$2,300 in-kind to the project.

Narrogin Toy Library currently has 21 family memberships, many families with more than one child borrowing toys. These members represent diverse cultural and social backgrounds.

NTL is a great community builder. Children learn about sharing toys, taking toys back and borrowing new toys.

In our current 'throw away' society, NTL promotes sustainability. Instead of having lots of cheap toys at home that breaks after little use and ends up at the tip NTL provides quality toys.

BACKGROUND

The Shire of Narrogin Chief Executive Officer noted that Cr Seale had declared an Impartiality Interest.

The Narrogin Community Support Association Inc are located in the offices at the bottom of Mackie Park on Fortune Street. Previously, they were known as Narrogin Youth Support Association Inc. The volunteers have been providing free financial counselling to the Narrogin community for over twenty years

SUMMARY

Narrogin Community Support Association Inc are seeking \$2,500 to effect much needed repairs and maintenance to their offices; replace ceilings, re-painting of the internal offices and upgrade the lighting in the offices.

COMMENT

Synergy records indicate that Narrogin Youth Support Association Inc and Narrogin Community Support Association Inc have not previously applied for Community Chest funds.

The building is owned by the Shire of Narrogin, the lessee, Narrogin Community Support Association Inc is required to cover the costs of maintenance such as painting. Repairs such as replacing ceilings is the Shire's responsibility, and should be budgeted for annually.

OFFICER'S RECOMMENDATION

That in relation to the Narrogin Community Support Association Inc application for \$2,500 from the 2018/2019 Community Chest, the Community Chest Reference Group:

- 1. Recommend that the Shire of Narrogin consider to undertake repairs in the 2019/2020 Building Maintenance Budget to
 - replace and paint the ceilings and install insulation to the value of \$6,500.
- Should support the application for \$2,500 for Narrogin Community Support
 Association Inc to purchase paint and undertake the work or appoint a
 contractor to undertake the repainting of the interior offices and / or upgrade
 the office lighting.



BACKGROUND

The Dryandra Archery Club are seeking \$2,500 from the 2018/2019 Community Chest fund to out-fit the clubs equipment trailer.

SUMMARY

As a result of dwindling membership, the Dryandra Archery Club applied for and received Community Chest funds in the 2016/2017 Community Chest round to purchase a second hand trailer for use as an equipment trailer to move equipment off-site and store it away from the clubs premises.

Due the ability to move equipment around, and set up at alternate venues to the clubrooms, the Dryandra Archery Club have successfully increased membership and are proposing to renovate and fit-out the trailer to render it more practical for its members.

The new trailer was acquired because the club needed to relocate to the YMCA Oval, which did not have on-site storage, to raise the Club's profile and reverse falling membership. This change has been highly successful with Club membership effectively doubling in the last 6 months.

The work proposed is to reline the interior of the removal trailer with plywood and, install a new plywood floor, build storage cupboards and lockers, and to provide some basic tea and coffee making facilities. Some renovation of the steel frame of the trailer will also be undertaken.

5. WHAT WILL THE COMMUNITY CHEST FUNDS PURCHASE?

The grant will be used to purchase materials with which to renovate the trailer, including timber (ply, MDF and treatened pine), cabinet fittings, hardware, and steel with which to repair part of the trailers steel frame.

7.1 BALANCE OF 2018/2019 COMMUNITY CHEST \$7,157

After assessing the nine applications from eligible community groups in which \$17,843 was requested from the 2018/2019 Community Chest, requests totalling \$15,343 were recommended by the Reference Group for endorsement at the next Ordinary Council meeting to be held on 26 September 2018.

In accordance with the guiding documents the Reference Group recommended an additional round of the 2018/2019 Community Chest be advertised in March 2010, to receive applications from eligible community groups for the remaining balance of \$7,157.

7.2 IMPROVED STANDARD OF APPLICATIONS

It was noted that the standard of applications received were a significant improvement on previous year's applications. This was due in part to reviewing the application form and amending it to allow greater detail to be recorded. The Reference Group wish to commend Shire of Narrogin staff for the improved standard of received applications.

7.3 REVIEW AND EDIT APPLICATION FORM

The Reference Group recommended that the Application Form be reviewed and edited, particularly in relation to the budget. It was noted that currently, the budget enables breakdown of income and expenditure relating to the requested funds, it doesn't enable applicants to detail the total project cost, including in-kind contributions.
