#### 6.1 PROPOSED BLUE TREE PROJECT – LIONS CLUB OF NARROGIN

Ms Carol McDougal of the Narrogin Lions Club presented to the Committee a proposal for a themed installation to recognise the national mental health initiative, Beyond Blue.


In an email to the Administration, Ms McDougal said "As representatives from the Narrogin Lions Club, they are passionate about the well-being of people in our community. We would like to invite the community of Narrogin to consider our proposal of the construction of a steel "blue tree" in recognition of the mental well-being campaign called "The Blue Tree Project." This initiative is about creating visual reminders to help spark difficult conversations, and encourage people to speak up when battling mental health concerns".

The proposal to the Committee was to consider if the "Blue Tree" could be placed in Narrogin.

At the conclusion of the presentation by Ms McDougal, the Committee members discussed the merits of the proposal in relation to the proposed location of the northern roundabout and the apparent lack of evidence to support the claims the Blue Tree Project has reduced the incidence of suicide.

The Committee members agreed they were not prepared to support the proposal at this time.

It was noted that the Administration would draft a letter to Ms McDougal thanking her for the presentation and relay the sentiments of the Committee members. However, Ms McDougal may wish to put the proposal to Council for its consideration.

#### 7.1 NARROGIN REGIONAL RECREATION CENTRE CARPARK TREE PLANTING

#### Summary

The Committee is requested to consider the proposal to plant shade trees in the carpark of the Narrogin Regional Recreation Centre (NRRC), Clayton Road as part of the carpark upgrade proposed for 2020/2021 and nominate the preferred tree species for planting.

#### Background

At the Narrogin District Townscape Meeting held on 7 February 2019, the Committee endorsed the Presiding Members *2019 Draft vision for the Committee* which included for consideration; planting shade trees in the middle of existing carparks.

#### Comment

The Administration proposes to upgrade the NRRC carpark in 20/21, the estimated cost to upgrade the NRRC carpark will be presented to Council to consider in the 20/21Draft Budget. The proposed upgrade will incorporate a plan to plant deciduous street trees in accordance with some of the recommendations contained in the *Shire of Narrogin Street Tree Planning: Selections and Recommendations Guide 2018* (the Guide).

The Guide however does not nominate a species, therefore the Administration suggests *Ulmus parvifolia,* one of four deciduous trees that are found to grow well in Narrogin, worthy to be used to create shade and meet the aesthetic expectations of a shade tree.

On the pages following, images of the proposed planting locations in the carpark and the suggested street trees have been included for your information.



The proposal aligns with recommendations in the 2016 Townscape Study Review – Greening the CBD; Reduce the heat island effect in summer; and Improve amenities for motorists including parking under shade.

#### **Financial Implications**

The cost to purchase, plant and handwater until established, the selected species is proposed to be incorporated within the 20/21 Draft Budget request. To upgrade the carpark, for Council consideration, inclusive of resurfacing the carpark and kerbing to protect the trees, the total cost is expected at \$117,548 (ex GST).

- 3. That with respect to the proposed resurfacing of the Narrogin Regional Recreation Centre carpark, the Committee recommend the estimated cost of \$97,454 be considered by Council in the 2020/2021 Draft Budget.

#### Summary

The Committee is requested to consider the proposal to plant approved species of plants at the fenceline along the western side of Pioneer Drive.

#### Background

At the Narrogin District Townscape Meeting held on 1 August 2019, the Committee resolved that the Administration proceed to explore partnerships, establish ownership and boundaries, and seek approval from the land owners; ARC Infrastructure and Main Roads, to develop an approved plan and species list to create a screen of vegetation on the fence on western side of Pioneer Drive.

#### Comment

The Administration has received approval from the land owners, Public Transport Authority (PTA) and Main Roads WA (MRWA) and anticipates planting will take place in May/June/ 2020.

This list below of recommended species was provided by MRWA Vegetation Coordinator of Narrogin as Australian native shrubs of this region that are extremely hardy, low maintenance and are available to purchase.

- Grevillea hookeriana
- Grevillea vestita

#### Summary

In the later part of 2019 whilst the Shire of Narrogin CEO was being briefed on the Narrogin District Hospital's proposed new Heli-Pad, Hospital staff mentioned that the date palms in the roundabout together with other trees within the Hospital grounds would be removed to make way for the Heli-Pad. It was noted that the selected palms and trees were to be cut down and taken to the tip.

#### Background

Conversations between the CEO and Hospital staff progressed whereby it was discussed that it would be great as a joint partnership, to save the four date palms, which are of heritage value and transplant them somewhere else in Narrogin. A few sites were considered and one site in particular presented as the most favourable being the Narrogin Regional Recreation Centre (NRRC).

The idea was presented at the Monthly Briefing Session in late 2019, whereby attending Elected Members voiced their support for the proposal. Former Narrogin and District Townscape Committee member, Mr Peter White was also consulted and supported the proposal.

#### Comment

It is envisaged that the palms will be transplanted to the grassed area at the front of the NRRC thereby creating an oasis/tropical effect i.e. palms near water – pool. Furthermore it was negotiated, that the WA Health Department would contribute \$3,500 towards the cost of transplanting of the palms, estimated total cost of up to \$7,000.

The palms will be transplanted (see attachment) in late April early May to the new location as the Hospital has a dead line of 30 May 2020 to remove the palms. Advertising of this will take effect closer to the time of transplanting.

#### Summary

The Committee supported the inclusion of Item 7.5 after it was presented as a late item by email to the Townscape Advisory Committee on Tuesday 18 February 2020, for consideration for inclusion in the meeting on that same day.

The Committee is requested to consider the development options in relation to the ablution building at Lot 103 Smith Street, Narrogin and to make a recommendation to Council which reflects best use of Council resources, demonstrated needs of the community and the surrounding retail district.

#### Background

Within the Narrogin CBD district, there are three public toilets. These are located at;

- Old Courthouse Museum Egerton Street;
- Mackie Park; and
- Smith Street (adjoining Coles car park).

There are also several businesses within this area that provide toilets for their patrons including; Nursery Café and Gallery; Duke of York Hotel; Shell Service Station (corner of Egerton and Earl Streets) and Narrogin RW Farr Memorial Library.

Lot 103 Smith Street, Narrogini is currently held freehold by the Shire of Narrogin. It is zoned 'Special Use – Car Park' under the Former Town of Narrogin Town Planning Scheme No.2. The subject property has a total area of 81m<sup>2</sup> and the building occupies less than 40m<sup>2</sup> total floor area.

The toilet block is located on the eastern side of the Coles carpark and it could be considered compliant in terms of accessibility as it has ramp access and ambulant cubicles.



Male – 1 x ambulant cubicle and 1 stand urinal with ramp access from the Coles carpark and steps from Smith Street entrance; and

Female – 1 x ambulant cubicle; 1 x standard cubicle with ramp access from the carpark.

Following the adoption of the 2019/2020 Budget, in which the amount of \$50,000 was allocated for the refurbishment or replacement of Smith Street toilets, the Shire's Administration obtained quotes from suitably qualified suppliers of public restrooms to supply a building which complies with *Access & Mobility Australian Standard No. 1428-2009*, for installation at the existing Smith Street public toilet site. (Attachment 1)

Quoted prices for an ablution block ranged from \$31,000 – over \$160,000. Design options were prefabricated and included a tilt up concrete and steel, and galvanised metal frames with Colorbond cladding.

The Administration sought to obtain a recommendation from the Narrogin District Townscape Committee regarding the preferred design and colour, however, the timing of the Biennial Local Government Election held in October 2019, meant the term of the Townscape Committee would expire on 19 October 2019. With no new Committee expected to be in place until early 2020, the Committee was invited by email on 17 September 2019, to review images, floor plans and colour options for the proposed new ablution building as a replacement for the Smith Street public toilet, and to respond with their preference.

The Committee replied with mixed responses, so taking into consideration the timeframe for completion of the project by the end of the 2019/2020 financial year, the matter was referred to Council at the meeting held on 27 November 2019.

#### Comment

At the Ordinary Council meeting on 27 November, Council was requested to support the Administrations recommendation to proceed with demolishing the existing building and purchase and install the prefabricated option recommended at the indicative cost of \$34,000.

#### Council resolved as follows:

"That with respect to the redevelopment of the Smith Street Ablution building at Lot 103 Smith Street, Narrogin, Council defer the project from the current financial year and request the Narrogin Townscape Advisory Committee to report back on the various matters listed under the strategic implications before 30 April 2020 and the budget for the project be reviewed at that time."

The Townscape Advisory Committee thus needs to consider and report back on the following matters:

- 1. Council has had commercial in confidence advice that a commercial retailer seeks to consolidate an existing CBD ablution facility to maximise patronage within a proposed establishment;
- 2. The Shire is awaiting advice from a retailer regarding opportunities to partner with the maintenance of or need for the ablutions as a local government asset;
- 3. The Shire maintains ablution's in the CBD at Mackie Park, the Museum and Smith Street and is currently building new ablution's in Memorial Park and the question could be asked whether there is an opportunity to consolidate Ablution facilities within the CBD including demolition of the existing Smith Street facility, in exchange for improving or developing another facility;
- 4. The Smith Street ablutions have always appeared an anomaly and whilst well utilised are in a problematic location;
- It could be argued that the existing ablution at the Museum are underperforming and could be expanded in a sympathetic heritage manner while still in reasonably close proximity to the Smith Street retail district;
- 6. Is the Smith Street facility required, given the close proximity of Shire and private (business) owned facilities?;
- 7. That the Smith Street facility remains operational and functional and could easily survive another 12 months without major repairs or refurbishment;
- 8. Could the \$50,000 be better utilised, in part, to provide for a concept design of a new facility abutting the existing ablution at the Museum? A design which clearly demonstrates community engagement and acceptance of the proposal.

To date, the Administration has had no formal application for the consolidation of an existing ablution asset by a potential commercial retailer. Based on this, no further consideration has been given to this point.

The Smith Street ablutions asset is owned by the Shire and one could consider that its main patronage would be Coles customers not just from this town, but regionally as well. An option well worth considering would be to engage with Coles administration and establish if they are interested in the purchase of the freehold land and ablution block; or to purchase just the land for additional parking bays. Upon receipt of a response from Coles, the Administration could further advise the Committee.

The option to demolish the Smith Street ablution block and not replace it, but instead refurbish the Museum ablution facility into a larger more modern facility with disability access has merit. This would require refurbishing the interior and possible exterior extensions. The exterior has heritage value and retaining its existing character and style would be a priority. However this would be a significant change and there may be varied opinion from the community.

The Smith Street ablution facility, although well used, has been the target of repeated vandalism and anti-social behaviour for a number of years. The facility looks tired and run down despite a number of attempts over the years to refurbish it.

In conclusion, if the current facility was to be demolished and not replaced, public consultation would need to be undertaken prior to commencement of any works to mitigate any community concern and invite feedback. The community may insist that these facilities remain and it is prudent that the public are made aware that the Smith Street facility is owned and maintained by the Shire, and is not the property of Coles.

The Administration therefore recommends that the proposal consider options to retain, remove or replace the Smith Street facility and that these be advertised for public comment for a period of at least 30 days and that all submissions received considered by the Committee and then presented to Council for further consideration.

The procurement of a prefabricated ablution facility would need to be compliant with the Shire's Purchasing Policy 3.1(b).

#### **Financial Implications**

An amount of \$50,000 has been allocated for this project to be completed in the 2019/2020 financial year.

Should this project not proceed in this financial year then these funds could be transferred to the Building Reserve as a potential contributory source for funding a project in the 2020/21 or future financial year.

Disposal of property will be in accordance with provisions in the Local Government Act 1995 s3.58.

In summary, the Committee has several strategic thinking decision paths;

- Recommend to the Council that they simply refurbish the facility within the \$50k Budget as per existing specification; or
- Recommend to the Council that they remove the toilets and replace them with modern full accessibility modular design toilets within the \$50k Budget (attachment 1); or

- Recommend to the Council that they utilise the Budget in 19/20 financial year for design of an in-situ built facility at an estimated cost of \$70k-\$120k (including engineering, design and construction cost) based on advice of a preferred style, design and parameters determined by the Committee; or
- Recommend to the Council that they consult with Coles regarding potentially transferring the asset to that entity (or land owner) and defer a decision regarding demolition or investment in nearby ablutions until engagement with Coles has concluded.

Key points;

- Do the Committee members think that they already have a feel for what the community would think about removal of ablutions at that location? If the answer is yes, then perhaps there is no need to consult?
- Can we presuppose what Coles might come back with and therefore this may be a moot point in even asking? If the answer is yes, then perhaps there is no need to consult?
- Do we have sufficient information at this time to make a recommendation to Council on one of the above preferred decisions?

Remembering that the Committee needs to report back to the Council by no later than 30 April 2020.

To achieve this deadline, a decision or at least advice to the Council with a recommendation, needs to be made by the Council's agenda deadline of 17 April 2020.




