COVID-19 Business Impact Rate Relief



Background

Council has resolved at its meeting of 28 April 2020, to support immediate rate relief packages for eligible businesses of the Shire, upon application and assessment, on the following basis and criteria:

- a. Up to 100% of local government rates, excluding Emergency Services Levy and Refuse charges, pro rata, from the date of any COVID-19 National or State declaration taking or having effect until its cessation or 30 June 2020, whichever is the earlier;
- b. Applications are to be in writing and determined jointly by the Shire President and Chief Executive Officer:
- c. Total Budget pool available is \$20,000;
- d. You must have a licensed retail / shopfront / physical business premises, available to the public to attend, in the Narrogin or Highbury townsites; and
- e. You must have been directly impacted negatively by National or State closure declarations.

Any approvals will be credited to successful applicants' next year's rates (no refunds) and priority for funding relief will be as follows:

- i) Cafes and Bakeries that were forced to close dining operations from 23 March 2020;
- ii) Beauticians, Masseuses and Spa's forced to close operations from 26 March 2020;
- iii) Hotels that were forced to close hotel operations from 23 March 2020;
- iv) Other Businesses that can demonstrate that as a DIRECT result of a declaration, that their business has been negatively affected.

Applications close 4.00 pm on 14 July 2020 and you will be advised of your business's success, or not and to what extent your rates might be credited by no later than 31 July 2020. Assessments are final and not subject to appeal or review.
